



2019 ASHL PLAYOFFS CONTEST

OFFICIAL CONTEST RULES

- 1. SPONSOR:** The 2019 ASHL Playoffs Contest “The Contest” is sponsored by Canlan Ice Sports Corp. “The Sponsor”, 989 Murray Ross Pkwy, Toronto, ON, M3J 3M4.
- 2. ELIGIBILITY:** The Contest is open to legal residents of Canada, who have reached the age of majority in the province at the time of entry, with the exception of employees of the sponsor, contest administrators, and any other parties engaged in the development, production, or distribution of Contest materials, and those living in the same household. Residents of Quebec are not eligible to participate. By participating in this Contest, entrants acknowledge compliance with, and agree to be bound by these Contest Rules. Entrants who do not comply with these Contest Rules are subject to disqualification by the Sponsor. Registered teams in the Adult Safe Hockey League “ASHL” at a participating location (Burnaby, Calgary, Etobicoke, Langley, North Vancouver, Oakville, Oshawa, Saskatoon, Scarborough, Winnipeg, York) during the “Winter 2018/19” season are eligible for contest entry. You are not eligible to enter or win if you are an employee of Canlan Ice Sports or any of their respective affiliates. For ASHL teams in participating locations that include an employee of Canlan Ice Sports or any of their respective affiliates on their roster, the team will have the ability to designate an individual on the team who is in no way affiliated or employed by Canlan Ice Sports as their designated contest entrant for the team. Any team that wins a nightly draw who has a Canlan employee accept the prize as the team’s representative will forfeit any prize without compensation.
- 3. HOW TO ENTER / NO PURCHASE NECESSARY:** Contest dates vary by location. See chart below for contest dates by participating location:

During the contest period, each ASHL team is eligible to participate in the Nightly Contest Draws based on the date that they have a scheduled league game. **Special conditions apply to eligible teams who are registered at Canlan Ice Sports – Calgary Great Plains. Please reference Section 5.1: Contest Drawings, for specific information on contest entry and drawing.** All teams that are scheduled to play on a contest-eligible date will receive one (1) ballot for contest-entry that will be located at the on-site Wild Wing or Thirsty Penguin restaurant. Where applicable, teams that are on a ‘bye week’ will still retain the ability to enter the draw on a regularly scheduled contest-eligible night, provided that they satisfy entry requirements. Teams that are not scheduled to play on a contest-eligible date will not be eligible to win the Nightly Contest Draw on that particular date. A registered player from the team is required to

physically submit their team’s pre-populated entry ballot into the designated ballot box prior to the nightly draw being conducted. Blackout dates within the contest period where no nightly contest draw will be conducted vary by location. See *Section 4: Contest Prize* for additional information on blackout dates. **Limit one (1) entry per team, per eligible nightly contest draw. No Purchase Necessary for ballot submission.** If it is discovered that any person has attempted to: (i) obtain more than the maximum stated number of entries as outlined in these Official Contest Rules and/or (ii) use (or attempt to use) multiple names and/or identities to enter the Contest, then he/she may be disqualified from the Contest and all of his/her entries voided. Your entry will be rejected if the entry form is not fully completed with all required information and submitted and received by the Entry Deadline. All entries are subject to verification at any time and for any reason. The Sponsor reserves the right to require proof of identity and/or eligibility (in a form acceptable to the Sponsor – including, without limitation, government-issued photo identification) to participate in this Contest. Failure to provide such proof to the satisfaction of the Sponsor in a timely manner may result in disqualification.

4. CONTEST PRIZE: The number of contest prizes varies by location. Blackout dates may apply by location. See chart below for full list of contest prizes and blackout dates by location.

Each contest prize available to be won is as follows: one (1) \$1,000.00 CAD voucher which is eligible to be applied towards the team’s future ASHL league fees in either the *Summer 2019* or *Winter 2019/20* season at the participating location from which the prize was awarded from. Voucher expires December 31st, 2019. The voucher cannot be used as part of a team’s deposit to hold a registration spot in a future season. **For contest winning teams, maximum limit of one (1) prize per team during the contest window. If a winning team is eligible for participation on a second contest-eligible date, they will not be permitted to be eligible to win a second contest draw.** Each prize does not hold a cash value and may not be substituted or exchanged for any monetary difference between the actual and stated value, if any. Prizes are not transferable or assignable and must be accepted as awarded with no substitutions in cash or otherwise, except at the Sponsor’s sole discretion. Sponsor reserves the right to substitute a Prize of equivalent monetary value if a Prize or any part of the Prize cannot be awarded as described for any reason. The Releasees (as defined below) will not be responsible, however, if weather conditions, Event cancellations, labour disputes, any national emergency, war, civil commotion, acts of terrorism, acts of government or any agency thereof or other factors beyond Sponsor’s reasonable control prevent a Prize or any part of a Prize from being fulfilled. In any such event, a winner will not be provided with a substitute Prize or cash equivalent. If any activity relating to any Prize is cancelled or postponed for any reason, the balance of the Prize may be awarded in full satisfaction of the Prize award. Prizes will only be released to the verified winner. Return of any Prize/Prize notification as undeliverable may result in disqualification and selection of an alternate eligible Winner.

5. CONTEST DRAWINGS: Nightly contest draws begin March 3rd at Canlan Ice Sports – Oakville and continue at participating locations through the contest window outlined in *Section 3 – How To Enter*. Winner selection will occur in a live draw at 9:30 p.m. local-time at the Wild Wing Restaurant or Thirsty Penguin Restaurant on each contest-eligible night. Participating facilities reserve the right to change the time of the nightly contest-draw without discretion and will make every effort to notify contest-eligible teams that would otherwise be impacted. **A representative from the Team must be on-hand at the time of the nightly draw. If no representative is there, the ballot will be disqualified, and another entry will be pulled from the ballot box. Teams that have submitted their ballot prior to a game but fall into the following scenarios will be eligible to win, even if they don't have a representative for the actual contest draw:** 1) Game is in-play during the time of the contest draw; 2) Game ends less than 15 minutes prior to the contest draw time; 3) Game starts less than 15 minutes after the contest draw time.

5.1 CONTEST DRAWINGS – CALGARY: Each ASHL registered team that is considered to be contest eligible will be eligible to win one of (10) contest prizes given out at the location as outlined in Section 4: Contest Prize. Commencing on April 14th, one (1) ASHL team will be drawn each day within the eligible contest window and receive one (1) contest prize. Eligible teams are permitted to win no more than one (1) prize during the contest window. Upon being drawn, a team will be removed from further draws within the contest window. Winning teams will be notified each day by a representative from Canlan Ice Sports – Calgary Great Plains. Odds of winning are dependent on the number of contest-eligible ASHL teams playing at Canlan Ice Sports – Calgary Great Plains.

6. SKILL-TESTING QUESTION: To be declared a Prize winner, the selected entrant(s) must first correctly answer, a mathematical skill-testing question without assistance of any kind, whether mechanical or otherwise. Sponsor will attempt to notify the selected entrant(s) by phone using the information provided at time of entry. If a selected entrant: (i) fails to correctly answer, or incorrectly answers, the skill-testing question; or, (ii) cannot accept the Prize as awarded for any reason whatsoever; then the Prize will be forfeited and the Sponsor has the right but not the obligation, in its sole discretion and time permitting, to select an alternate eligible entrant from among the remaining Qualifiers.

7. RELEASES, ETC: Before being declared a winner of a Prize, a selected entrant will be required to sign a Declaration of Compliance and a Release of Liability form, in which the selected entrant (among other things): (i) confirms compliance with these Official Contest Rules; (ii) acknowledges acceptance of the applicable Prize as awarded; (iii) releases the Sponsor, Canlan, from any and all liability in connection with this Contest, his/her participation therein and/or the awarding, use and/or misuse of the Prize or any portion thereof; and (iv) agrees to the publication, reproduction and/or other use of his/her name, address, voice, statements about the Contest and/or photograph or other likeness without further notice or compensation, in any publicity or advertisement carried out by or on behalf of the Sponsor in any manner whatsoever, including print, broadcast or the internet. The Releasees do not make, nor in any manner are responsible or liable for: (i) any warranty, guarantee or representation, expressed or implied, in fact or in law relative to any Prize, including but not limited to its quality, merchantability, fitness for purpose or mechanical condition; and (ii) are not liable for injury, loss or damage of any kind resulting from the acceptance, use and/or misuse of any Prize, travel related thereto (as applicable), or otherwise from participation in this Contest. Declaration and Release documents must be returned within the time period indicated in the documents or the applicable Prize will be forfeited. The name(s) of guest(s) and/or teammates cannot be changed once the Declaration and Release of Liability form(s) have been received by Sponsor or its agent.

8. PERSONAL INFORMATION: By entering this Contest, entrants consent to the collection, use and disclosure of their personal information for the purposes of administering the Contest, including, but not limited to, for the purpose of receiving one or more messages, whether electronic or not, from the Sponsor or its designated representative, which may provide entrants with information regarding the Contest or otherwise further the administration of the Contest. The entrant will be deemed to have solicited these messages from the Sponsor by virtue of entering the Contest. By accepting the Prize, winners consent to the collection, use and disclosure to the public of their names, addresses (city, province/territory), voices, statements and photographs or other likenesses for publicity purposes in connection with the Contest in any media or formats, including but not limited to the Internet, without further notice, permission or compensation. Personal information will not otherwise be used or disclosed without consent. This section does not limit any other consent(s) that an individual may provide the Sponsor or others in relation to the collection, use and/or disclosure of his/her personal information.

9. LIMITATIONS OF LIABILITY: Without precluding the limitations of liability set forth elsewhere in these Official Contest Rules and/or the Declaration of Compliance and Release of Liability, and for greater certainty, the Releasees will not be liable for: a) any incomplete, illegible, or inaccurate information, whether caused by any equipment or programming associated with or utilized in the Contest, or by any technical or human error which may occur in the capturing and/or processing of entries; b) the theft, loss, destruction or unauthorized access to, or alteration of, entries; c) any problems with, or technical malfunctions of, telephone networks or lines, computer on-line systems, servers or providers, computer equipment, software, viruses or bugs; d) any failure of any entry to be received by or from Sponsor and/or entry to be captured or recorded for any reason including but not limited to traffic congestion on the Internet or at any website or combination thereof; e) damage to a participant's or other person's system occasioned by participation or downloading of materials in this Contest; f) any typographical or other errors in the offer or administration of this Contest, including but not limited to errors in advertising, these Official Contest Rules, the selection and/or announcement of eligible Qualifiers and/or Prize winner(s), and/or the distribution of any Prize(s); and/or g) any combination of the above.

10. RIGHT TO TERMINATE, SUSPEND, OR AMEND: Sponsor reserves the right to terminate, suspend or amend this Contest, in whole or in part, without prior notice.

11. MISCELLANEOUS: All decisions of the Sponsor, or any contest judging organization as designated by it, are final and binding without right of appeal in all matters relating to this Contest and by entering this Contest, all entrants agree to be bound by these Official Contest Rules. The Releasees will not be responsible for illegible, incomplete, lost, misdirected, affected by equipment failures, errors, failures or late entries which will be void. Any use of automated devices is prohibited. All entries become the property of Sponsor and will not be acknowledged or returned. No correspondence will be entered into except with selected entrants (or any other entrant(s) as deemed necessary by the Sponsor). Contest is subject to all applicable federal, provincial and municipal laws. In the event of a dispute regarding who submitted an entry, the entry will be deemed submitted by the authorized individual possessing the e-mail address of the submitted survey.

Sponsor reserves the right at its sole discretion to disqualify, from this Contest and any future Contest or other promotion conducted by Sponsor, any individual that it finds or believes to be not in compliance with these Official Contest Rules; to be tampering with the entry process or the operation of the Contest or Contest Website; or to be acting in an unsportsmanlike or disruptive manner, or with intent to annoy, abuse, threaten or harass any other person. ANY ATTEMPT BY AN ENTRANT OR ANY OTHER PERSON TO DELIBERATELY DAMAGE ANY WEBSITE OR TO UNDERMINE THE LEGITIMATE OPERATION OF THE CONTEST IS A VIOLATION OF CRIMINAL AND CIVIL LAWS AND,

SHOULD SUCH AN ATTEMPT BE MADE, SPONSOR RESERVES THE RIGHT TO SEEK DAMAGES FROM ANY SUCH PERSON TO THE FULLEST EXTENT PERMITTED BY LAW.

Subject only to applicable law and any required regulatory approval, the Sponsor reserves the right and without prior notice, to adjust any of the dates and/or timeframes stipulated in these Official Contest Rules, to the extent necessary, for purposes of verifying compliance by any entrant or entry with these Official Contest Rules, or as a result of any technical or other problems, or in light of any other circumstances which, in the opinion of the Sponsor affects the proper administration of the Contest as contemplated in these Official Contest Rules, or for any other reason.

In the event of any discrepancy or inconsistency between the terms and conditions of these English Official Contest Rules and disclosures or other statements contained in any Contest-related materials, the terms and conditions of these English Official Contest Rules shall prevail, govern and control to the fullest extent permitted by applicable law.
